Leadership

In 2018, MSS leadership went through a significant transition as Lyth Hartz, our President since 1999, made the difficult decision to retire after 39 years with MSS. Losing somebody in a leadership role with Lyth's passion, dedication, and experience can be challenging.

Fortunately for the people we support, their families, and MSS staff members, the right person for the job was already on our team, making this leadership transition easier.

Julie Johnson, who has served MSS for 28 years in various roles, was unanimously chosen by MSS' Board of Directors to be our new President/CEO.

"Julie has delivered tremendous results for MSS in her previous roles and we are confident MSS will continue to flourish under her leadership," MSS Board Chairman Tom Lyman said.

Transition to MSS

MSS is about providing opportunities. For Stacie Sampson, who transitioned to MSS Eagan in May 2018 from another program, the opportunities here have allowed her inner-artist to flourish. "I can do all the things I love here," Stacie says. "I really like art, singing, and going on community outings and I didn't have the chance to do them before I came to MSS. I've been a free-drawer my whole life, but I can do so many more things with art here at MSS."

Stacie works closely with Eagan Art Facilitator, Lara Hanson, and the collaboration has been a great one. "Lara really helps me when I have a question or when I'm working on an idea for a drawing or a painting," Stacie says. "Everyone here at MSS is great to work with because they ask what I want to do and then help me do it."

Stacie has had pieces of art displayed at The Show Gallery Lowertown in St. Paul and has even sold a piece of her work during an event at our Eagan location. "My goal is to have some art work sold at The Gallery," Stacie says confidently. "I'll keep working at it and Lara will help me reach that goal."

Drawing and painting are not Stacie's only artistic endeavors. She also enjoys singing and considers herself an accomplished karaoke crooner. "I really like to sing songs about family and relationships," Stacie says. She sings karaoke on Mondays in Eagan. "I have made a lot of friends here at MSS and I feel welcome here because of singing and participating in the art program. MSS has made my life better because I get to do so many more activities now."

Creative Arts

Creative arts programming at MSS has steadily evolved and grown since its inception 20 years ago. In 1999 we had a single staff member focused on the arts. Now, we have an 8-person art department, including a dedicated Art Facilitator at each of our locations.

In 2018, we added a robust fiber arts program to our menu of options. This has led to a higher level of independence for the people we support to design what they want.

New fiber arts opportunities include embroidery, knitting, fiber dying, and weaving. Participants in the program, using adaptive equipment if needed, can create their own materials and turn them into wall tapestries, scarves, hats, or anything their imagination can dream up.

"The response we have seen from the program participants has been incredible," says MSS Director of Arts Development, Lauren Hughes. "We have different fiber arts options all five days of the week."

We look forward to additional transitions in our creative arts program that will challenge the people we support, offer a variety of opportunities, and exceed their expectations.

If a person we support is looking for employment, MSS will help that individual transition into the workforce. Peggy Ramey, with MSS for more than two decades, worked in our production services facility in St. Paul, which offered her steady work and in-house supports.

After the decision was made to transform the St. Paul work space into the Community Hub, Peggy and her support staff knew a transition had to be made. "I enjoy being able work," Peggy says. "I like the work opportunities here at MSS."

With an encouraging staff behind her, Peggy made the decision to participate on MSS community-based, supervised work crews, which provides her the opportunity to continue to earn a real paycheck and receive MSS full-time supports while working in the community.

That transition has led Peggy to become a valued team member working at our Spectrum Plastics and Sick, Inc. partner sites where she works on a variety of light assembly and kitbuilding jobs.

"I'm happy that I still have the opportunity to work," Peggy says. "I can earn my own money and save it or spend it on whatever I like."

At MSS, we believe everyone has the right to work. To help make those goals a reality, we provide information, training, and support so the people we serve can make informed decisions about working.




